## Resilience

## Resiliency & Mental Health Resources

What is resilience? Coming back after challenges or setbacks.

## Relationships

Building positive relationships is very important. It helps to create a caring and safe school environment where students, families and staff feel safe and welcome.

### Reflection

The opportunity to reflect will provide the time to look back and allow you to gain insight into how to move forward as you finish out this school year. However, more important, it takes a temperature on how you are doing now, and will help you develop a sense of self-awareness.

#### Resources

It is important to create a caring, safe community that aligns with Tier 1 of the MTSS (Multi-Tiered System of Supports), a framework that helps allocate support resources to students based on data-driven assessments. Tier 1, primary intervention, supports all students by setting up classroom-wide systems for students and staff. When schools identify a child at risk, the student receives specialized attention as part of Tier 2 or Tier 3 prevention levels. Providing a caring school setting may reduce the need for higher-level services.

The Florida Department of Children and Families is returning to its normal process for Medicaid renewals, a process called Medicaid redeterminations or renewals.

This means you may need to reapply for benefits so the state of Florida can redetermine your eligibility and you can keep Medicaid benefits. If you lose coverage, there are options.

## September is Suicide Prevention Awareness Month

A time to raise awareness of this stigmatized, and often taboo, topic. We use this month to shift public perception, spread hope and share vital information to people affected by suicide. Our goal is ensuring that individuals, friends and families have access to the resources they need to discuss suicide prevention and to seek help.

Your school can get the following designation "Suicide Prevention Certified School" by completing the following requirements:

- All instructional personnel are required to complete two hours of a department-approved youth suicide awareness and prevention training every three years;
- ♦ The youth suicide awareness and prevention training must be included in the district's continuing education or master inservice plan;
- The school has at least two school-based mental health services providers that are qualified to conduct a suicide risk assessment using a department-approved screening instrument; and
- The school or district has a policy requiring the use of an approved suicide risk assessment instrument administered by a school-based mental health services provider prior to requesting or initiating an involuntary examination due to concerns about a student's suicide risk.

# **Supporting Students Transitioning from Alternative School Settings - Webinar Recording**

## Region 9 Comprehensive Center (R9CC)

The webinar featured a panel discussion with students and staff from West40, R9CC advisory board members, and experts on how youth-serving adults can best support students transitioning from non-traditional settings, such as alternative schools, to traditional school settings. Students and panelists discussed how teachers and school staff can create a more welcoming and positive learning environment; how schools can pair students with a significant adult in their school; and how staff can communicate more transparently to support students during their transition. Students and panelists also discussed how schools can better address disciplinary issues and what that looks like in practice. The event highlighted recommendations and insights from an infographic developed from focus groups conducted by the Region 9 Advisory Board with students at West40.
