Antraneise- The telemedicine guidance states that coverage is available for evaluations performed by school district behavioral provider staff. Can you clarify that the telehealth guidance pertains only to that part of the evaluation that would have been face-to-face and that other reimbursable parts of the evaluation that do not involve face to face interaction with the student (development of evaluative reports, interviews, and other activities that are part of the evaluation) are still reimbursable?

Please confirm that nursing services provided while the students are not at the school building, such as compilations of health histories, health care coordination and referrals and consultation with other health care staff and parents continue to be reimbursable.

Thank you once again for the telehealth guidance.
